

PRODUCER PRICE INDICES IN 3TH QUARTER OF 2013

Compared to **Q2 2013**, **agricultural producer** prices went down by 6.0% in **Q3 2013**. Prices of cereals and oil plants were lower (-16.6%, -12.1%, respectively). Prices of fresh vegetables also fell by 8.8%. Prices of potatoes and fruit were higher (+46.6%, +9.5%, respectively). Among animal products price decreases were recorded in eggs (-13.7%) and cattle for slaughter (-2.8%). Prices of pigs for slaughter and milk went up by 9.1% and 2.4%, respectively.

Prices of **agricultural producers** in **Q3 2013** compared to **Q3 2012** were higher by 1.4%. Prices of crop products fell by 2.6%. Animal products increased (+6.8%). Lower prices in crop products were mainly affected by prices of oil plants (-8.5%), cereals (-7.1%) and fruit (-3.0%). Prices of potatoes (+71.5%) and fresh vegetables (+24.9%) increased. Prices of animal products were higher due to price growth of milk (+15.0%), poultry (+7.8%) and pigs for slaughter (+5.6%). Prices of eggs and cattle for slaughter were lower (-24.2% and -3.2%).




In the third quarter of 2013 compared to the second quarter of 2013 industrial producer prices increased by 0.2%. Prices went up the most in 'coke, refined petroleum products' (+3.7%), it was in comparison to second quarter the increase by 8.3 p.p. Prices were higher in 'food products, beverages, tobacco' (+0.6%). Prices were lower in 'mining and quarrying' (-2.0%), 'electrical equipments' (-1.3%) and 'basic metals, fabricated metal products' (-0.6%).





Prices of **industrial producers** increased by 0.7% in the third quarter of 2013 (+0.5% in the second quarter of 2013), **year-on-year**. Prices went up in 'electricity, gas, steam and air conditioning' (+3.6%), 'food products, beverages, tobacco' (+3.4%) and 'transport equipment' and 'furniture, other manufactured products' (+1.2% both). Prices went down in 'coke, refined petroleum products' (-3.8%) and 'basic metals, fabricated metal products', 'basic pharmaceutical products' and 'mining and quarrying' (-2.0% all).





According to an estimate, **construction work** prices in **Q3 2013** compared to **Q2 2013** were lower by 0.2%; prices of construction material input decreased (-0.3%). According to an estimate, **construction work** prices **in Q3 2013 compared to the corresponding period of 2012** decreased by 1.4%, prices of construction material input decreased by 0.5%.

In comparison to Q2 2013, prices of market services decreased by 1.5% in Q3 2013. Lower were especially prices of 'telecommunication services' (-8.0%) and 'advertising and market research services' (-9.9%). Increasing were prices in 'postal and courier services' (+5.0%). Prices of market services excluding advertising services were lower by 0.6%. In Q3 2013, prices of market services fell by 2.1% in total compared to Q3 2012. Price decreases were recorded for 'land transport services and transport services via pipelines' (-3.6%), thereof 'freight rail transport services' (-13.6%). Prices of 'warehousing and support services for transportation' went down by 8.8%, thereof 'storage' were lower by 19.8%. Prices in 'telecommunication services' also fell by 21.0%. Higher prices were in 'advertising and market research services' (+5.6%), thereof 'advertising services' (+6.4%). Prices of market services excluding advertising services fell by 2.7%.
