
2.12 OTHER CIVIL RESEARCH (SEO 12)

This socio-economic objective covers all civil research that could not be classified as one of the specific socio-economic objectives. Funding to support R&D abroad (e.g. Framework programmes) is included here as well as fees for participation in international R&D projects. An important item in this case is the money given to the further development of R&D infrastructure. This chapter also includes R&D whose characteristics forbid to classify it into specific chapters (e.g. because of confidentiality).


- The development of the absolute amount of state funding within SEO 12 and this objective's share of the total GBAORD are shown in the following figure, which shows that the absolute amount of support varied in the period 2002–2009. The highest amount (CZK 1,549 million) allocated to this objective was recorded in 2007. The highest proportion of total GBAORD was detected in 2003 (8.5%). The average annual growth in the period reached 7.5%.
- As mentioned before, this socio-economic objective is not further divided into subcategories and therefore a different figure shows the breakdown by type of funding. Institutional funding was far more common than project funding, when the share of institutional funding in 2009 was 90.5% (CZK 1,110,058 thousand) compared to only 9.5% (CZK 116,114 thousand) of project funding.
- The largest provider of state funding for this socio-economic objective was the Academy of Sciences with the share of 60.5% (CZK 741,317 thousand) in 2009. Another major provider was the Ministry of Education, Youth and Sports with the share of 12.9% (CZK 158,492 thousand), which funded mostly foreign programmes. Also, the Office of the Government of the Czech Republic is listed as a provider of funding for SEO 12 with the share of 1.3% (CZK 16,165 thousand). Amounts related to transfers of funds and administration that could not be clearly assigned to a specific provider are classified under the heading unspecified (16%; CZK 196,036 thousand).
- The largest beneficiaries of funds under other civil research were government departments with the share of 86.6% (CZK 1,064,365 thousand) of funds received. A total of 7.2% went to programmes and contributions related to international research and development (international governmental institutions – CZK 88,491 thousand).
- The breakdown by region shows that the largest beneficiary was the capital city of Prague (CZK 922,868 thousand; 75.3%). Shares in other regions did not exceed 1%. The category "unspecified", which includes amounts whose beneficiary by region is impossible to identify and beneficiaries outside the Czech Republic, amounts to CZK 285,346 thousand, which corresponds to the share of 23.3%.
