

INTRODUCTION

This is the twelfth publication in the series of “Foreigners in the Czech Republic” published by the Czech Statistical Office. The first one was issued in December 2001.

The publication concentrates, in a complete manner, data on foreigners who have chosen the Czech Republic to be their domicile or habitual residence, i.e. locality of a long-term residence, have found jobs, or have been conducting business activities here, and those, who came to the Czech Republic to escape political persecution or severe economic conditions in their native countries. Data for the year 2011, as frequently supplemented with time series of data for the previous years, make this publication focal point. Since there is not enough space in the hard copy version of this publication, data for all years, which they are available for, are not included in tables containing time series. This publication issuing is based, the same way as in the previous years, on a Decision of the Government of the Czech Republic (this year it is the Decision of the Government of the Czech Republic No. 6 of 4 January 2012). Similarly to the publications issued before, the information presented in this book was gained from information systems administered by the Ministry of the Interior of the CR, Ministry of Labour and Social Affairs of the CR, Ministry of Industry and Trade of the CR, Ministry of Justice of the CR, Ministry of Education, Youth and Sports of the CR, Ministry of Health of the CR, and the Czech Statistical Office, and coordinated by the editorial board composed of representatives of all the aforementioned institutions. It is the Ministry of the Interior of the CR, which initiated the publishing of this book and which since 2008 has undertaken repeatedly the role of the coordinator for implementation of the concept of integration of foreigners on the CR territory.

Because of repeated editions of the publication its layout has become substantially stable. In accord with requirements made to the CZSO recent publications have more emphasised the subdivision of foreigners into groups by their citizenship, that means into foreigners coming from the EU Member States and those from the so-called third countries. Table 3-18. Foreigners not holding work permit, who were caught doing illegal works during controls, by citizenship was omitted in Chapter 3 Economic activities of foreigners. The reason for is a change to the data collection method by the Ministry of Labour and Social Affairs of the CR, which now does not allow to obtain the aforementioned data broken this way. On the contrary, Table 4-4. Secondary schools – foreign students by field of study, was newly added into Chapter 4 Education of foreigners. Therefore numbering of next tables has changed.

Respective information systems store records on foreigners, which cannot be mutually compared in every case. It is not intentional in order to make the orientation in the information on foreigners more complicated - it is rather caused by the fact that the respective information sources are adjusted to the needs of the relevant ministry, which they were established at, and the process of harmonization of data sources to obtain their mutual comparability is in no case an easy one. In order to make clearer, which foreigners respective tables provide information on, please, consult summary table on the next page (numbers of tables relate to this year's issue of the publication).

Dear readers, if you have some comments on the contents and form of the publication presented, now it is the right time to inform us about it, so that we can take them into account while preparing the next issue of the publication.
