6 Land ownership, lease of land – types of holdings

FSS 2005 confirmed results from previous structure surveys that a great share (85.7%) of agricultural land utilised by the interviewed holdings is rented from the others. Concerning the holdings of natural persons, a share of their own land went down by 7.4 percentage points in comparison to 2003. In terms of holdings of legal persons a moderate increase (by 1.0 percentage point) in the share of their own land was recorded.

23 598 holdings of natural persons farm solely on their own agricultural land; their total area is 147 620 ha, i.e. on average 6.3 ha per 1 holding. Moreover, these holdings own another 61 301 ha which they rent to other holdings. In the category of the smallest (by area) holdings of natural persons, the ownership of land is a condition of farming. The more land a holding utilises, the higher share of land rented from the others it has.

It is obvious that holdings of legal persons are of the rental type in the Czech Republic. 43.4% of 2 629 holdings of legal persons farming on agricultural land have no agricultural land of their own. Their number decreased by 13% in comparison to 2003. Arable land makes up 76.8% of the total area of leased agricultural land (878 926 ha). In terms of holdings of legal persons there are 236 holdings farming solely on their own land (total area of this self-owned land is 51 967 ha). Moreover these holdings own another 2 222 ha which they rent to other holdings.

There are no significant differences in the amount of owned land among the various legal forms of holding. As was mentioned above, the more area a holding utilises the smaller is the share of its own agricultural land. This phenomenon is the most significant in the largest holdings, i.e. in cooperatives, with a share of 2.9% of their own land.
