Statistics - Investment in the Future

Statistics is a significant investment in the future - all depends on what statistical data are produced and how the data are applied. A sufficient description of both short-term trends and the comprehensiveness of indicators on the long-term development and state of economy bring knowledge crucial for decisions made by politicians, strategists and economic policy makers, which especially applies to governments and central banks. Statistical data also provide information of key importance for the work of researchers and scientists as well as for the every-day orientation of both businesses and citizens. Their significance grows with emerging new phenomena and processes such as the EU enlargement, globalisation, and the need to deal with life conditions of society, including social affairs.
