A. FINANCIAL AND INSURANCE ACTIVITIES

This subchapter presents basic information on enterprises, principal activity of which classifies them according to the Classification of Economic Activities (CZ-NACE) to the section K – Financial and insurance activities:

- 64 Financial service activities, except insurance and pension funding
- 65 Insurance, reinsurance and pension funding, except compulsory social security
- 66 Activities auxiliary to financial services and insurance activities

The data included in this subchapter were obtained from annual surveys; only for some indicators information from quarterly surveys was used. The statistical surveys taken in enterprises with financial intermediation as their principal activity are of the exhaustive type and cover all incorporated entities irrespective of the number of employees.

Notes on Tables

Table 20-1. Basic indicators of banking financial institutions

Selected financial indicators on institutions classified to the CZ-NACE group 64.1 are presented. The institutions covered are commercial banks, savings banks, and the Czech National Bank. The financial indicators are defined according to the chart of accounts for banks.

Table 20-2. Basic indicators of non-banking financial institutions

Information characterizing incorporated enterprises classified to the CZ-NACE groups 64.2, 64.3, 64.9, 66.1, 66.2, and 66.3 is presented. It particularly covers investment funds, investment companies, financial leasing companies, factoring companies, stockbrokers, insurance brokers and other non-banking financial institutions. These entities keep accounts according to the chart of accounts for banks or businessmen.

Due to the transition to the new CZ-NACE classification (a Czech version of the NACE Rev. 2), data in the Table **20**-2 are not comparable with data published in the Statistical Yearbooks of the CR before 2009.

Within recalculation to the new CZ-NACE classification, administrative data from the Ministry of Finance of the CR and other institutions were widely used in estimation models in 2010 for the first time. At the same time, some misclassifications were retroactively revised.

Table 20-3. Basic indicators of insurance and reinsurance institutions

This table includes information on enterprises classified to the CZ-NACE groups 65.1 and 65.2, i.e. insurance companies specialized in life insurance, various kinds of non-life insurance, or combined insurance companies (providing both life and non-life insurance) and reinsurance companies. The financial indicators are defined according to the chart of accounts for insurance companies.

Table 20-4. Basic indicators of pension funds

Pension funds carrying out pension funding (with contributions from the state) are classified to the CZ-NACE group 65.3 and keep their accounts according to the chart of accounts for banks.

The content of the indicator "payables from supplementary pension insurance contributions, total as at 31 December" is the same as the content of the indicator "supplementary pension insurance reserves, total as at 31 December" published in Statistical Yearbooks of the CR until 2012.

B. OTHER MARKET SERVICES

This subchapter presents basic information on enterprises, principal activity of which classifies them to the following CZ-NACE sections:

- L Real estate activities
- M Professional, scientific and technical activities
- N Administrative and support service activities
- P Education
- Q Human health and social work activities
- R Arts, entertainment and recreation
- S Other service activities

The data included in this subchapter were obtained from annual surveys. As a rule, enterprises with 20+ employees are covered all and data on enterprises with a lower number of employees are obtained by a sample survey. The "P4-01" survey (among small businesses of selected production industries), which was the data source for the years 2005–2009, was cancelled in 2010 and data are modelled from the administrative data.

Notes on Tables

Tables 20-5 to 20-10. Other market services

These tables contain basic indicators on businesses classified to the following CZ-NACE sections: L, M, N, P, Q, R, and S. The data in tables include information on incorporated legal persons as well as natural persons doing business on the basis of the trade licence or other authorization. Only businesses, which operate primarily for the purpose of making a profit are included in other market services. Part of businesses classified to the sections P, Q, and R belong to the non-business sphere (organizational units of the state, semi-budgetary organizations partially funded from the state budget or local government budgets, and non-profit organizations) and data on them can be found in other chapters of the Statistical Yearbook of the CR.

Definitions of indicators are stated in Chapter 19 Transportation, Information and Communication.

Due to the transition to the new CZ-NACE classification (a Czech version of the NACE Rev. 2), data in tables are not comparable with data published in the Statistical Yearbooks before 2009.

The CZSO made an ordinary revision of the year 2010, which enhanced quality of previously published data by inclusion of administrative data obtained later, correction of misreported data, and refinement of classification of enterprises by principal activity according to the CZ-NACE classification. Similar reasons led also to an occasional revision of data for 2008 and 2009, by which methodological comparability in the period of 2008 to 2011 has been accomplished. Data for 2011 are preliminary.
