

## 22. MARKET SERVICES

### A. FINANCIAL AND INSURANCE ACTIVITIES

This subchapter presents basic information on enterprises whose principal activity classifies them to the following CZ-NACE divisions:

64 – Financial service activities, except insurance and pension funding

65 – Insurance, reinsurance and pension funding, except compulsory social security

66 – Activities auxiliary to financial services and insurance activities

The data included in this subchapter were obtained from annual surveys. For some indicators, however, information acquired through quarterly surveys was used. The statistical surveys taken in enterprises with financial intermediation as their principal activity (CZ-NACE 65 to 67) are of the exhaustive type and cover all incorporated entities irrespective of the number of employees.

#### Notes on tables

##### Table 22-1. Banking financial institutions: basic indicators

Selected financial indicators on institutions classified to CZ-NACE Group 64.1 are presented. The institutions covered are commercial banks, savings banks, and the Czech National Bank. The financial indicators are defined with reference to the chart of accounts for banks.

##### Table 22-2. Non-banking financial institutions: basic indicators

Information characterizing incorporated enterprises classified to CZ-NACE Groups 64.2, 64.3, 64.9, 66.1, 66.2 and 66.3 is presented. It particularly covers investment funds, investment companies, financial leasing companies, factoring companies, stockbrokers, insurance brokers and other non-banking financial institutions. These entities keep accounts according to the chart of accounts for banks or businessmen.

Due to the transition to the new CZ-NACE classification (Czech version of NACE Rev. 2), data in Table 22-2 are not comparable with data published in previous yearbooks.

Within recalculation to the new CZ-NACE classification, administrative data from the Ministry of Finance of the CR and other institutions were widely used in estimation models for the first time. At the same time, some misclassifications were retroactively revised. Data result from the retroactive recalculation of structural data for the years 2005–2007, which has not been finalized, yet, by the deadline of the Statistical Yearbook as the process is demanding as for time and methodology. Results provided in this table are thus only preliminary and might be further revised.

##### Table 22-3. Insurance and reinsurance institutions: basic indicators

This table includes information on enterprises classified to CZ-NACE Groups 65.1 and 65.2, i.e. insurance companies specialized in life insurance, various kinds of non-life insurance, or combined insurance companies (providing both life and non-life insurance) and reinsurance companies. The financial indicators are defined according to the chart of accounts for insurance companies.

##### Table 22-4. Pension funds: basic indicators

Pension funds carrying out pension funding (with contributions from the state) are classified to CZ-NACE Group 65.3 and keep their accounts according to the chart of accounts for banks.

*L – Real estate activities*

*M – Professional, scientific and technical activities*

*N – Administrative and support service activities*

*P – Education*

*Q – Human health and social work activities*

*R – Arts, entertainment and recreation*

*S – Other service activities*

*The data included in this subchapter were obtained from annual surveys. As a rule, enterprises with 20+ employees are covered all, and data on enterprises below 20 employees are obtained by sample surveys.*

#### **Tables 22-5 to 22-10. Other market services**

*These tables contain basic indicators on businesses classified to CZ-NACE Sections L, M, N, P, Q, R, and S. The data cover incorporated legal persons as well as natural persons doing business on the basis of the trade licence or other authorization. Included in other market services are only businesses which operate primarily for the purpose of making a profit. Part of businesses classified to sections P, Q, and R belong to the non-business sphere (government departments, semi-budgetary organizations partially funded from state and territorial budgets, and non-profit organizations) and data on them can be found in other chapters of the Statistical Yearbook.*

*Definitions of indicators are set out in Chapter 15. Industry.*
